Counterfeit currency – film money not sufficiently realistic to be counterfeit.

Allegation of unregistered currency exchange

R v CH, Aylesbury Crown Court

Insolvency service prosecution concerning the sale of an accountancy firm.

### **Serious Violence**

R v TA, St Albans Crown Court

Workplace scrap where injured party lost two teeth. Self-defence raised successfully.

R v SA, St Albans Crown Court

Represented vulnerable person, not fit to plead, through to hospital order. Issues of law of unproven misconduct when considering restriction orders

### **Human Trafficking, Slavery, Prostitution & Facilitation**

#### **Operation Motely, Southwark Crown Court**

Allegation of trafficking women into brothels, controlling prostitution and selling drugs.

#### **Operation Widow, Southwark Crown Court**

Allegation against “financier” of human smuggling OCG

### **Drugs**

#### **Operation Venetic, Kingston Crown Court**

Encrochat evidence used to accuse a person of multiple counts of drug importation. Raised issues of duress and modern slavery.

### **R v AL**

PWITS B proved to be simple possession

### **Driving Offences**

R v SZ, Winchester Crown Court

Death by dangerous driving alleged. Jury found only careless in line with plea.

R v SE, St Albans Crown Court

Case of aggravated vehicle taking, failure to provide and no insurance. Statutory minimum disqualification ordered across all offences.

### **Confiscation, Cash Forfeiture and Cash Detention**

Surrey Police v SA, Staines MC

Cash forfeiture – prejudicial interview and contentious drug swab evidence excluded.
